Port Removal

How should I prepare for this procedure?

- You may eat and drink as normal prior to this procedure.
- For Gainesville procedures, you will need to arrive an hour and a half before your scheduled appointment time. For Braselton procedures, you will need to arrive an hour to an hour and a half before your scheduled appointment time. For Barrow procedures, you will need to arrive an hour before your scheduled appointment time.
- A nurse from the Interventional Radiology department will reach out to you via phone the day before your procedure.
- For your safety, you must have a caregiver or responsible adult with you to drive you home after your procedure. Due to the effects of anesthesia, sedation, or other post-procedural effects, you will not be able to drive yourself. Additionally, the responsible adult accompanying you will assume responsibility for you upon discharge. This person should be someone who can provide support and care as needed while you recover.
- Certain blood thinners need to be held for this procedure. You will need to check with your primary care provider that it is acceptable for your blood thinners to be held for this procedure.

What should I expect when I arrive?

- For Gainesville, you will go to the registration department in the Blue tower of the hospital. When you arrive in the main lobby of the Blue tower, go down the hallway on your left. The registration department is located on the right. Labs will be drawn here if necessary.
- For Braselton, you will go in through the main entrance and check in at the desk. You will be directed to registration from there. Labs will be drawn here if necessary.
- For Barrow, you will go to the registration desk located inside the main entrance of the hospital.
- After registration, you will go to the radiology waiting room. A staff member will show you back to the Interventional Radiology department. Your driver can accompany you back to the prep area.
- A provider and nurse will explain the procedure, go over discharge instructions, and decide what medications can be safely given. An IV for medication administration will be placed if necessary.
- Dressing change instructions and supplies will be provided.
- When it is time to go to the IR lab for your procedure, your driver will be shown to the waiting room.

What medications will be offered during this procedure?

- In certain cases, pain management is commonly offered for this procedure. Medications offered will be dependent on the provider's discretion on the day of your procedure. Pain management is intended to help with any discomfort experienced during the procedure. You will be awake for this procedure.
- The medication most commonly used for pain management is Fentanyl.

What should I expect during my procedure?

- When it is time for your procedure, your nurse will take you to the IR lab.
- The provider will be paged to the procedure room when your nurse and tech are ready.
- The provider will numb the area with lidocaine.
- A small incision will be made at the site of your implanted port.
- The implanted port and the catheter that has been inside your vein will be gently removed.
- The port and catheter will be inspected to make sure that all the parts have been removed. Part of the catheter may be tested for bacteria.
- The incision will be closed with stitches (*sutures*), adhesive strips, or skin glue.
- A bandage (*dressing*) will be placed over the incision. The health care provider may apply gentle pressure over the dressing for about 5 minutes.

What should I expect after my procedure?

- Minor discomfort may be present that should be controllable by over-the-counter medications (Tylenol, Ibuprofen, etc.) or whatever you normally take for pain at home. No pain medication prescriptions will be provided on discharge. Any significant pain post-procedure would warrant a trip to the ER or a call to the ordering physician.
- There is no recovery time for this procedure. You will be discharged home after your procedure is complete.
