The Lighthouse Foundation has a mobile clinic that visits 34 sites throughout Georgia. At each clinic, qualifying individuals can receive a fully dilated eye exam and one pair of eyeglasses, which are produced at our Chamblee clinic. The clinics allow our Clinic Managers and partner doctors to diagnose and treat serious eye conditions before the client experiences permanent vision loss. Patients can also receive follow-up care for chronic eye conditions, such as glaucoma and diabetic retinopathy.

A few reminders about the hearing aid program:

- You will be contact via mail or email two-three weeks after we have received your application. This letter will inform you of your application status.
- There is a co-payment associated with your hearing aids. It is based on the style of aid your provider recommends, as well as on your monthly income. There are no payment plans.
- You may submit a hearing test from a non-Lighthouse approved provider with your application; however you will need to choose a Lighthouse-approved provider to move forward in the program. He or she will have to accept the hearing test you already have, or they will require you to get a new one with them. To be safe, try to get your hearing test done with a Lighthouse-approved provider. Please read our [New Patient Letter & FAQs](#) for more information.
- The cost of the hearing aid package is based on a **sliding scale**
- The client's household size, income, and type of hearing aid needed will determine the cost of the package (ranges from \$95-\$260 per aid)
 - Georgia residency for at least one year
 - Income within 200% of Federal Poverty guidelines
 - Current hearing test (less than 6 months old)
 - Georgia ID
- Hearing tests are not covered
- Hearing aid package includes:
 - Up to 2 digital hearing aids
 - A 3 year service warranty per aid
 - A 1 year loss and damage warranty per aid
 - One set of ear molds

- Four appointments with approved Lighthouse Provider
- The Georgia Lions Lighthouse Foundation requires: ONE form of identification, ONE proof of residence, and THREE proofs of income. Please bring copies of these with you to your appointment. *If you are unable to provide the required documents at all, please make a note of it in the comments section.
 - **ID includes:** GA Driver's Licence, Georgia ID Card, Georgia Birth Certificate, Voter's Registration Card
 - **Proof of residency includes:** Copy of first page of your lease agreement, Mortgage Statement, Letter from home, shelter, or transitional home stating that you live at that location (on letterhead and signed by home/shelter employee, Something that comes through the mail, in your name, to your address (ex:utility bill, bank statement, Social Security letter, library card)
 - **Proof of income includes:** Last year's tax return, Last 3 months of bank statements, 3 current pay check stubs, Social Security Administration Award Letter. (If you receive direct deposit, circle the item on the bank statement), Food Stamp papers from DFACS (award summary), Letter from nursing home stating amount received for personal expenses, Unemployment Claim/Wage Inquiry statement, Information, including monthly amount received, of any other sources of income (ex: TANF, pension, retirement, child support)
